Per School Board Policy 438, the school district shall require that volunteers assigned to work with students at overnight and/or off-campus activities shall submit to a criminal history background check as specified by the school district. All overnight or off-campus volunteers must have a completed background check on file at the district office prior to working with District #831 students.

Please complete the appropriate portion of the attached background investigation form.

- Auxiliary Volunteer Request Form for Background Investigation-Online: The top part of the form is for those who are able to complete the background check information online. After we receive the form, you will receive an email from Trusted Employees with the link to their secure website so that you can complete the background authorization online and pay for it online. The cost is \$22.50. We strongly recommend the online process which will have a quicker response time.
- Auxiliary Volunteer Permission and Release Form for Background Investigation (If unable to process online): The bottom portion of the form is for those who are unable to complete the form online. A check in the amount of \$22.50 payable to Forest Lake Area Schools must accompany the completed form.
